









## What is the Open Government Partnership?

OGP was launched in 2011 to provide an international platform for domestic reformers committed to making their governments more open, accountable, and responsive to citizens. Since then, OGP has grown from 8 countries to the 65 participating countries indicated on the map below. In all of these countries, government and civil society are working together to develop and implement ambitious open government reforms.




### Number of datasets






# NL compared with UK and US






## Who opens the data? (2014)

## Conclusions 2014

- **Open data are the standard, but not yet the practice:**
  - Effectuate the concept of “open, unless”
  - Also concentrate on data on what the government does.  
How is taxpayers’ money being spent?
- **The success of open data policy will depend on:**
  - Greater insight into what data are available
  - Creating the right conditions for open data.
  - The government must invest in both the supply and the demand sides of open data (Open Data Institute)



## Conclusions 2015

- **Steady advance:**
  - Governmental data survey
  - Departments commit themselves more to open data
- **Offering open data still unilaterally and fragmented:**
  - Almost all datasets are GEO data.
  - The national open data portal acts not as such and open data can be found at different places.



## Points for attention

- Define goals and milestones in a concrete action plan
- Make opening of data mandatory
- Develop a National Information Infrastructure
- Get started with opening data, in the social domain  
decentralizations for example
